

The Lennox and Addington Stewardship Council Bursary Application Form

RULES GOVERNING THIS BURSARY

1. The applicant must satisfy the criteria listed below.
2. The applicant must be a graduate of a recognized secondary school.
3. Priority will be given to applicants entering a field of Environmental or Natural Resource Studies at a recognized college or university. In addition, students applying to programs in a field of Science applicable to environmental study and students applying to Sustainable Agriculture Studies at a recognized college or university will be considered.
4. The applicant must supply a valid copy of his / her current secondary school transcript showing his / her marks to date. (SEE **Special Criteria** BELOW)
5. The bursary shall be in the amount of \$500.00 Canadian and will be awarded upon proof that the intended recipient has been accepted into his / her program of study at college or university.
6. The decisions of the Lennox and Addington Stewardship Council regarding the recipients of all bursaries shall be regarded as final.
7. **The deadline for application for this bursary is June 12, 2020.**

CRITERIA

1. The recipient must be a current resident of Lennox & Addington County.
2. The recipient must be pursuing in this year post-secondary education in a recognized college or university as outlined in Rule 3 above.

Special Criteria for 2020:

Recipient must provide:

- a) Graduation and acceptance into a post-secondary institution
- b) Mid-term marks submitted to post-secondary institutions
- c) All extra-curricular participation up to March break, 2020
- d) Any extra-curricular participation after March break where social distancing has been confirmed to have been practised.
- e) Any other details/ features you think may be useful to this evaluation process.

Regarding applications for the Bursary and the signature from a school staff member: if it can be obtained electronically, that is fine. If this is difficult, we will waive that requirement.

We are adding a request that students obtain comments from a Student Services advisor or teacher regarding their application. In previous years, we have sometimes received a reference from Student Services staff or a teacher on the application, which is always very helpful. Considering the strange circumstances this year, we think that having some comments from school staff (a brief reference for the student) would be beneficial to our assessment process. This can simply be in the form of an email message, it does not have to be a formal letter.

AMOUNT OF BURSARY

There will be one bursary available, in the amount of \$500.00.

APPLICATION

Applicants must apply on the application form supplied by the Lennox & Addington Stewardship Council by June 12, 2020. These forms will be available through the Student Services Department of L&A secondary schools.
